

## **HEERF Tuition Assistance Application Spring Semester 2022**

*(Messaging incorporated into the application process)*

**Applications must be submitted by the final day of classes for your SPRING 2022 semester.**

The Higher Education Emergency Relief Funds II and III (HEERF II and HEERF III) provide funding to institutions of higher education to support college students with direct emergency cash grants in cases where student's lives and educations have been affected by the coronavirus outbreak. Northcentral Technical College received \$741,189 in HEERF II funding and \$3,597,609 in HEERF III funding to provide direct relief to help qualifying students impacted by COVID. These emergency assistance grants will be funded 100% with Higher Education Emergency Relief Funding; no College resources will be used.

Northcentral Technical College recognizes that the impact of COVID may have caused unanticipated financial challenges for our students.

### Examples of How the Coronavirus Emergency Student Tuition Assistance Fund Can Be Used

- tuition (amounts can be applied to tuition, books, course materials, and other charges on your student account for current or past terms)
- to request assistance with course materials, technology, healthcare (including mental healthcare), food, housing, childcare, transportation, or tuition (not directly applied to your student account) please complete the HEERF Emergency Relief application.

### Additional Items of Note

- Funds awarded do not need to be repaid, and are not subject to federal taxes.
- Based on the U.S. Department of Education's current guidance, NTC is prioritizing students with exceptional need, such as those who receive Pell Grants. The funds are limited. Not every eligible student may receive funding, and selected students may receive only a portion of their unmet need or emergency costs.

### Eligibility Requirements for an Emergency Grant

- We are currently accepting submissions for the Spring 2022 semester. An application to request funding for future terms may be available at a later date.
- Students must be enrolled in college-level credit for the semester for which they are requesting assistance. If you are uncertain of your enrollment status, please contact your student success advisor.
- Students may not apply until your classes are in progress. Please wait until after your course start date to apply.

- Students whose enrollment is part of continuing education and dual credit coursework or contract training through the NTC Workforce Training & Professional Development are excluded and do not qualify.

Applications can only be submitted after enrollment in Spring 2022 courses has been completed. Please submit your application once you've enrolled.

These funds will be awarded on a first-come, first-serve basis. Eligible student's award amount can range from \$0 to a maximum of \$2,000. Please see below for the awarding methodology.

Enrolled Post-Secondary Credits	Tuition Assistance Amount
1 – 2 credits	\$0
3 – 5 credits	\$600
6 – 11 credits	\$1,100
12 or more credits	\$2,000

Tuition Assistance Fund award amounts will be the total amount of tuition and fees for the fall semester minus any grant, scholarship and third-party funds awarded for that semester at the time of the calculation of the Tuition Assistance Fund amount. If a student has already made payments, they will get refunded.

If you do not consent to have the Tuition Assistance award applied to your NTC student account and have an emergency situation, we encourage you to connect with your advisor through your Starfish Success Network in Canvas or by calling 715.803.1797.

HEERF funding is specifically for financial hardship resulting from COVID. If your financial hardship is not related to COVID, please connect with your Student Success Advisor to discuss eligibility for NTC Student Emergency Fund assistance. Not sure who your advisor is? I consent to apply the full amount of any emergency funding to my tuition/account balance. The amount awarded will only be applied to the current term.

You will be notified of your Emergency Grant Assistance result via NTC Student email.

Tuition assistance awards will be applied to any unpaid charges on your account based on your consent provided in the application. Overpayments on your account due to payments you may have already made will be refunded to you.

You do not need to repay Emergency Grant Assistance funds awarded.
